Home Science College, Sector-10, Chandigarh" as per the terms & conditions, addressed to The Principal, Govt. Home Science College, Sector-10, Chandigarh, to reach by January 16, 2023 during working hours.

Terms & Conditions:

- Firm/ agency/consultant/experts should be ISO 9001/ ISO 21001/ ISO 14001/ ISO 17020/ ISO 50001Certified as required by NAAC. Agency accredited either by NABCB or any member AB of IAF. The certificate should carry the logo of the AB concerned, for detailed Green Audit/Environment Audit and Energy Audit of Govt. Home Science College, Sec-10, Chandigarh. And the report submitted by the firm should satisfy all requirements of NAAC.
- 2. Agency Should have professionally qualified degree holder and experienced Energy Auditor duly certified and accredited by Bureau of Energy Efficiency (BEE). Supporting evidence/documents need to be submitted along with the documents pertaining to the pre-qualification criteria.
- 3. Agency Should have the experience of carrying out at least two Green/Environment Audit & Energy Audit in college/university/institute or multistoried office buildings in the last 5 years.
- 4. The Agency should procure all the instruments and equipments to be used in the audits, by itself, with valid calibration certificates.
- 5. Auditors should carry their own calibrtaed tools and tackels to the site for Testing and demonstrating the savings.
- 6. Next one year's action plan to be given for continual improvement including seeking certification.
- 7. Firm should not have been blacklisted/debarred by any Government organisation /PSU. An undertaking to this effect must be attached with the technical bid.
- 8. The firms have to quote the full & final rates inclusive of all the taxes.
- 9. The Audit activities shall include the following:
 - Pre-Audit: Meeting with College technical team, Visual inspection of the site & verification of various documents regarding energy consumption and electrical installation.
 - Audit: Auditing and performance analysis
 - Submission of Draft report to college and discuss the report with College's

representative.

- Submission of Final report to college after incorporating the changes as per discussions with the College.
- Green/Environment Audit & Energy Audit should be conducted in conformity to the relevant directives.
- 10. All the reports and certificates should be provided in hard as well as soft copies.
- 11. No travel, lodging and boarding charges etc. will be given.
